BYLAW NO. 5/88

A BYLAW TO MAINTAIN, REGULATE AND CONTROL A CEMETERY

The Council of the Town of Hanley in the Province of Saskatchewan enacts as follows:

- 1. The term "municipality" in this bylaw shall mean the Town of Hanley.
- 2. That part of the North East quarter of Section 35, Township 30, Range 4, west of the 3rd meridian, in the Province of Saskatchewan, acquired by the municipality for cemetery purposes as approved by the Registrar under the Cemeteries Act shall be and is hereby appropriated as a public cemetery to be called the Hanley Cemetery.
- 3. (a) No burial shall be made in the Hanley Cemetery unless a plot is purchased from the Administrator of the municipality and a licence is granted.
 - (b) The licence shall be in Form I, Appendix A, attached to and forming part of this bylaw.
- 4. It shall be lawful for the licencee of a lot or his agent to place markers and/or head stones and plant flowers thereon in accordance with the provisions of this bylaw.
- 5. If any tree or shrubplaced before the signing of this bylaw, by means of its roots or branches or otherwise, becomes detrimental to an adjacent lot or lane, the council may direct the removal of such tree or shrub or parts there-
- 6. The council may direct the removal of any markers and/or headstones, covers, trees, shrubs or flowers placed contrary to this bylaw or those existing markers and/or headstones, covers, trees, shrubs or flowers that become damaged after informing the licencee of their intent.
- 7. The internment of destitute persons shall be in such portions of the grounds as may be designated from time to time by the council.
- 8. The Administrator of the municipality shall keep an accurate record setting forth the name, the location of burial, and the date of burial of the deceased person.
- 9. The price of the lots in the Hanley Cemetery shall be as follows: 7
 \$50.00 per lot
 \$100.00 per double let

- \$100.00 per double lot

One person may not purchase more than two double lots in a row unless approved by council.

- 10. The purchaser of a lot shall be given a form with the description of the lot purchased. The form shall be in Form II, Appendix "A", attached to and forming part of this bylaw.
- 11. Any person found guilty of an infraction of any of the provisions of this bylaw shall be liable under bylaw 4/85, that being a bylaw to provide for penalties for contraventions of bylaws (General Penalty Bylaw).
