

BYLAW No. 1/90

A BYLAW TO PROVIDE FOR THE ENTERING ONTO AN AGREEMENT FOR THE USE OF FIRE FIGHTING EQUIPMENT.

The Council of the Town of Hanley, in the Province of Saskatchewan enacts as follows:

1. The Town of Hanley is hereby authorized to enter into an agreement with the Councils of:

The Town of Dundurn


The Resort Village of Thode

EXHIBIT "A" TO BYLAW NO.

FIRE PROTECTION AGREEMENT

THIS AGREEMENT MADE IN DUPLICATE THE 12th DAY OF February A.D. 1909 BETWEEN:

The Rural Municipality of Dundurn No. 314, Resort Village of Thode, Resort Village of Shields and the Town of Dundurn.

(hereinafter referred to as the "RM of Dundurn")

OF THE FIRST PART

- and -

The Rural Municipality of Rosedale No. 283, and The Town of Hanley.

(hereinafter referred to as the Hanley-Rosedale Fire Protection District)

OF THE SECOND PART

To share the use of fire fighting equipment belonging to the respective municipalities within the Hanley-Rosedale Fire Protection District and the RM of Dundurn.

THIS INDENTURE WITNESSETH AS FOLLOWS:

1. That the Hanley-Rosedale Fire Protection District and the RM of Dundurn may carry out work or service with any fire fighting equipment belonging to the two districts.
2. That the work or service shall be carried on for the purpose of fighting fires or for the protection of persons and property.
3. That the work or service shall be carried on within the Hanley-Rosedale Fire Protection District and the RM of Dundurn.
4. Rates for work and service set by each district shall apply for the use of its equipment and shall be paid between Fire Districts.
5. In the event for any reason, it may be necessary to cancel the Agreement, either parties by district may do so by giving written notice.
