

BYLAW NO.13/79

A BYLAW TO PROVIDE FOR THE ENTERING INTO AN AGREEMENT FOR USE OF FIRE FIGHTING EQUIPMENT.

The Council of the Town of Hanley, in the Province of Saskatchewan enacts as follows:

1. The Town of Hanley is hereby authorized to enter into an agreement with the Council of:

Rural Municipality of McCraney No.282

Rural Municipality of Lost River No.313

Rural Municipality of Rosedale No.283

the terms of which are attached hereto and form part of this bylaw, for the purpose of sharing the use of fire fighting equipment within the Hanley-Rosedale Fire Protection District and the Kenaston Fire Protection District.

Memorandum of Agreement made the 5th day of August, 1979.
BETWEEN

- (1) Village of Bladworth
- (2) Village of Kenaston
- (3) R.M. of McCraney No. 282
- (4) R.M. of Lost River No. 313
- (5) R.M. of Rosedale No. 283
- (6) Town of Hanley

to share the use of fire fighting equipment belonging to the respective municipalities within the Hanley-Rosedale Fire Protection District and the Kenaston Fire Protection District.

THIS INDENTURE WITNESSETH AS FOLLOWS:

- 1) That the Hanley-Rosedale Fire Protection District and the Kenaston Rural Fire Protection District may carry out work or service with any fire fighting equipment belonging to the two districts.
- 2) That the work or service shall be carried on for the purpose of fighting fires or for the protection of persons and property.
- 3) That the work or service shall be carried on within the Hanley-Rosedale Fire Protection District and the Kenaston Rural Fire Protection District.
- 4) Rates for work and service set by each district shall apply for the use of its equipment and shall be paid between Fire Districts.
- 5) In the event for any reason, it may be necessary to cancel the Agreement, either parties by district may do so by giving written notice.
