

BYLAW NO.6/83


A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT RESPECTING THE JOINT FUNDING OF THE CONSTRUCTION OF CERTAIN CULTURAL/RECREATIONAL FACILITIES.

The Council of the Town of Hanley, in the Province of Saskatchewan, enacts as follows:

1. The Town of Hanley is hereby authorized to enter into an agreement, attached hereto and forming part of this bylaw and identified as Exhibit A, with the following municipality:
R.M. of Rosedale No.283
for the purpose stated within the agreement.
2. The Mayor and Clerk of the Town of Hanley are hereby authorized to sign and execute the attached agreement identified as Exhibit A.





Memorandum of Agreement made this 9th day of June, 1983.

Between:

TOWN OF HANLEY

and

R.M. OF ROSEDALE NO.283

Whereas pursuant to the provisions of Bylaw No.6/83 of the Town of Hanley and Bylaw No.2/83 of the R.M. of Rosedale No.283, the parties hereto are authorized to enter into an Agreement to provide for the sharing of the construction, renovation or acquisition of a cultural/recreational facility/ facilities and services and the operating and maintenance expenses thereof according to the details attached;

And whereas the parties hereto have agreed to enter into such an agreement for the purpose of sharing certain cultural/recreational facility/facilities, services and expenses thereof so as to permit each of the parties hereto to levy upon the assessed value of assessable property shown on the Assessment Roll necessary sums of money to be applied toward the provision of cultural/ recreational services and capital works expenditures in connection therewith in accordance with the provisions of section 246(353) of The Rural Municipality Act(The Urban Municipality Act) and all amendments thereto;

Now therefore this Agreement witnesseth that in consideration of the terms, covenants and conditions to be observed and performed by each of the parties hereto;

Details of Agreement

a) Hanley Centennial Building Addition located on Lots 8,9,10, 19, 20 and 21, Block 3, Plan 54632 and Lots 11, 14, 15, 16, 17, 18, 22 and 25, Block 3, Plan C 1407

b) Capital contribution to a cultural/recreational facility development by each municipality will be Town of Hanley - \$12825.00, R.M. of Rosedale No.283 - \$10958.00

c) Net operating and maintenance costs of the facility shared by the participating municipalities at the same level as municipalities contributed to the cost of construction, renovation or acquisition in comparison to the total project cost;

d) The designated operating and controlling authority of the facility will be the Town of Hanley

e) Either party may terminate the agreement by giving thirty(30)days notice in writing if above provisions are not met.
