BYLAW NO. 19/19

A BYLAW OF THE TOWN OF HANLEY TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER SERVICES

The Council for the Town of Hanley, in the Province of Saskatchewan, enacts as follows:

- 1. This bylaw shall be cited as "The Water and Sewer Rates Bylaw".
- 2. That the charges to be paid by the water consumer whose water service has been turned on shall be those set out in the attached schedule marked as "A"; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
- 3. That, persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge as set out in the attached schedule marked as "B".
- 4. That the schedule attached and marked as "C" shall be in effect for existing connections subject to the quarterly infrastructure fee.
- 5. a) Accounts for water service and/or sewer service shall cover a period of three successive months, and shall be rendered on or before the first day of the month next following such periods.
 - b) Where the consumer does not occupy the premises for three successive months, the charges pursuant to clauses 2, 3 and 4 will be prorated to the nearest week.
- 6. If an account is not paid within the said period of 30 days, the water service may be disconnected. When the water service is so disconnected, it shall not be resumed until all arrears have been paid together with a reconnection fee of \$50.00. If the reconnection to reinstate the said service is at a time other than the municipal employee's regular working hours, the reconnection fee shall be \$75.00.
- 7. A penalty of two percent (2%) per month shall be charged to all water and sewer rates and charges unpaid the proceeding month-end after the billing date, and each month thereafter that they remain unpaid
- 7. That Bylaw No. 14/18 is hereby repealed.
- 8. That the rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on January 1, 2020 and on approval being issued by the Saskatchewan Municipal Board.

SCHEDULE "C" TO BYLAW NO. 14/18

The following infrastructure fee shall be in effect for those users that:

1) Did not opt to pay a one-time payment of \$4,600.00 prior to December 31, 2010;

Or

2) Are a new connection to the water service, required to make a one-time payment of four thousand, six hundred dollars (\$4,600.00) in accordance with "The Water and Sewer Management Bylaw";

To be paid for the period from October 1, 2010 until, September 30, 2025, the retirement date of the long-term debt on the rural water utility infrastructure.

Quarterly Infrastructure Fee:
