**TRANSFER STATION INFORMATION NOTICE
OF ITEMS ACCEPTED AT THE TOWN OF HANLEY TRANSFER STATION**

In accordance with our permit and Loraas Disposal the following items will **NOT** be accepted at the transfer station:

1. Tires;
2. Hazardous wastes of any kind: pesticides, chemicals which are radioactive, reactive, toxic, ignitable, corrosive, pathological, acidic, etc., or any waste which is otherwise listed as a hazardous or toxic substance;
3. Petroleum, petroleum remains or by-products;
4. Fuel tanks or oil barrels;
5. Asbestos, concrete, rocks, wire;
6. Petroleum contaminated soils;
7. Automobiles and other large metal objects;
8. Remains of or by-products of slaughter house operations;
9. Liquid domestic sewage, used oil, liquid wastes and sludges generally;
10. Liquid paints and solvents (dried material and empty cans are OK in the Loraas bin);
11. Acid-filled automotive batteries;
12. Propane tanks;
13. Any wood products treated with creosote (telephone poles, wooden pilings, railroad ties, etc.)

There are designated areas for steel. **ONLY TREES OR UNTREATED/UNPAINTED LUMBER MAY GO IN THE BURNING PIT.** Contact the Town Office regarding bin rental.

ANIMAL CONTROL

If you haven't purchased your dog and/or cat licenses, the Animal Control Officer will be getting in touch with you first with a warning then with a fine. Animal Licenses are available at the Town Office for \$25 per animal.

Our bylaw states that "every owner of a cat or dog that is over 4 months old shall, within 30 days of becoming the owner, obtain a license for each cat or dog." The owner of the cat or dog shall ensure that the animal wears a collar to which the tag shall be attached whenever the animal is off the premises of the owner.

The licenses expire Dec. 31 of the year purchased. We are unable to identify microchips, therefore the tag is necessary but the microchip information must be provided to the Town Office prior to Feb. 1 along with the annual license fee.

Kennel permits for breeders are \$100 per year (Jan. 1 to Dec. 31) and also must be purchased prior to Feb. 1.

Hanley Housing Authority

Hanley Housing Program

The Hanley Housing Authority on behalf of Saskatchewan Housing Corporation, offers the Social Housing Program. This program is designed to ensure that safe, adequate housing is available to those who could not otherwise afford it. Our tenants benefit from a safe place to call home, a community they can enjoy and peace of mind.

General Requirements for Housing

Applicants must meet income and asset limit requirements to be eligible for the Housing Program. All applicants are required to complete an application form and provide verification of income and assets, as requested.

Review Process

Applications are reviewed for eligibility and approved by the Housing Authority Board of Directors. We utilize a point score system that considers adequacy, suitability and affordability when determining the priority of need.

Once approved, units are allocated upon availability on a priority based, point score system.

Additional Information Senior housing rent is based on income – 30% of gross household income, collected via pre-authorized payment.

Units are smoke free – No smoking in the units by tenants or guests. Housing tenants are responsible for obtaining and paying for their own power. Heat, water/sewer are included in the rent.

Any questions related to the Hanley Housing Authority should first be directed to the manager.

All requested income information and previous landlord references must be included or application will not be processed.

TOWN TIDBITS

A study was completed by the staff at DRWU with the following information on **average** daily water consumption per household:

2 people = 72.82 gallons per day or 6,553.8 gallons per quarter

4 people = 114.1 gallons per day or 10,269 gallons per quarter

6 or more people = 175.4 gallons per day or 15,786 gallons per quarter

The Town Office had 70 people sign up for e-Billing for their utility bills. That will save the Town \$70 in postage and a few paper cuts for Clerk, Kim Bursaw! If you would like to sign up for e-Billing, please contact the Town Office to sign up.

NOTES FROM THE TOWN OFFICE

At our February Meeting:

A budget amount was approved for the Foreman to ensure that he had a proper winter safety jacket. When speaking with Deator Schacher about this, he invited our Foreman over to his house as he had a lot of promotional safety wear on hand from his company. Deator graciously donated a number of safety wear to our Foreman. Thanks Deator!

Councillor Richard McGregor and Administrator Darice Carlson attended the SUMA Convention in Saskatoon from Feb. 5 – 8. There is always a lot of information and networking to gain during the 4 days. Foreman Ben Collins went to Saskatoon one morning so they all visited a number of trade show presenters to get ideas on different products and services available. Richard presented the Council's concern of RCMP detachment fees to the Ministry of Justice segment and we were to await a response from the local detachment.

The Human Resources committee interviewed four candidates for the Clerk position and made a recommendation to Council to hire Kim Bursaw as a part-time Clerk. Kim accepted the position and started her position on March 1.

The CAO reported that she had attended an Asset Management workshop hosted by the WaterWolf Planning Commission. It was an intense two days but with a couple more days of working on the project, an Asset Management Plan was completed. Councillor Melissa Maddocks has offered to review the plan with the CAO for approval by Council.

A concern was reviewed on the "trickle lines" that were installed in a few houses following the cold winter where there was freezing of lines from the main to the houses. After discussing the concerns, a letter was drafted to hopefully assuage those concerns.

SaskTel has informed the Council that they have expanded to supply LTE in Hanley. They had been working on-site for a number of days.

Utility arrears were reviewed and the council decided to apply arrears of one property to the tax roll for that property.

Richard McGregor was re-appointed as Deputy Mayor.

The Municipal taxes were abated on the property where the Town stores gravel, asphalt & sand.

A temporary street closure for the westernmost portion of the 100 Block of Lincoln St. was approved for a street hockey tournament and dance fundraiser hosted by the Artificial Ice Committee.

The contract for a natural gas supply was renewed with Connect Energy for a term of five years.

At our March meeting:

New Councillor Elissa Moate swore her Oath of Office. Welcome to Council Elissa!

Commander Gregg Abbott of the Saskatoon Detachment RCMP attended the meeting to address concerns in regards to staffing.

The water has been turned on to supply the industries west of the tracks and those companies should be receiving water soon.

The Council is checking out a different product for dust control and considering a test strip once more information has been received.

CAO Darice Carlson is your appointed representative on the Dundurn Rural Water Utility Board. Now that the Phase 3 project grant funding has been completed the Board is working on calculations of the costs of Phase 3 as of the end of the Building Canada Fund date.

Your appointees to the Fire Board attended a meeting Feb. 23. The RM Administrator, Danielle Hache was appointed as Treasurer with Town CAO Darice Carlson remaining as the Secretary. The RM and Town Council are planning to meet as a whole to consider a Corporate Bylaw to put the Board under one umbrella board rather than having the separation of the two municipalities looking after their own assets.

The Council reviewed an advance booking system for the campground that the CAO created and the caretaker and Town Office can access. Fees and charges, deposits and signage were also discussed with a decision to collect a 10% non-refundable deposit for campground users that pre-book 3 or more sites.

Correspondence received from Cuclenaere, Kendall, Katzman and Watson LLP was reviewed with the decision that the letter should be returned as the Council has forwarded the issue to Credit Bureau Collections.

The software company that the Town uses is providing a number of webinars so Clerk Kim Bursaw is to be registered for pertinent classes that she can take during office hours. If you come in to the office and see her concentrating on her computer and headset, she is likely taking a webinar.

The Council looked at bunnyhugs and are considering doing a group purchasing so keep your eyes open for further information on that!

The Ag Society is hard at work planning this year's fair June 16 & 17 and Councillor Andrea Townsend updated Council on some of the plans for the weekend. The Ag Society makes very generous donations to different organizations or projects after the fair so the Council agreed to waive water and waste fees.

QUICK FACTS ON CO

WHAT IS IT: A colourless, odourless and tasteless gas.

SIGNS: Stuffy air, water vapour, backdraft and soot from a fireplace.

SYMPTOMS: Headaches, weakness, nausea, vomiting and loss of muscle control. They can be mistaken for flu symptoms.

EFFECTS: If inhaled, carbon monoxide deprives the blood of oxygen. Prolonged exposure can lead

to unconsciousness, brain damage or death.

CAUSES: Blocked or dirty vents, flues, chimneys and furnaces, as well as improper ventilation of burning fireplaces or woodstoves.

DEATHS: Approximately 200 per year.

PREVENTION: Annual inspection and cleaning of:

Furnaces

Chimneys

Fireplaces

Other fuel-burning equipment such as gas dryers.

SAFETY TIPS ON HOW TO AVOID CARBON MONOXIDE POISONING

INSTALL at least one carbon monoxide detector in your home.

ENSURE a wood or coal-burning stove is properly installed and vented. **DON'T** operate a gasoline-powered engine, kerosene stove or charcoal grill in a closed space.

BARBECUE grills should never be operated indoors.

CHECK clothes dryer vents that open outside the house for lint.

CHECK forced air fans for proper ventilation.

If you suspect carbon monoxide in your home, get out!

Drinking Water Quality and Compliance Annual Notice to Consumers

The Water Security Agency (WSA) requires that at least once each year waterworks owners provide notification to consumers of the quality of water produced and supplied as well as information on the performance of the waterworks in submitting samples as required by a Minister's Order or Permit to Operate a waterworks.
