**RULES RULES RULES!****TOWN OF HANLEY  
SWIMMING POOL BYLAW**

It's that time of year where there may be a number of swimming pools popping up in the community. The Council for the Town of Hanley wish to remind residents of the "Swimming Pool" bylaw.

Some of the key points of the Bylaw are:

- The definition of a "private swimming pool" is "an artificial pool of water having a depth at any point of 18" or more and/or has a surface area of 100 sq.ft. or more, and is constructed or erected on private property for the principal use of the occupants of the premises, and includes both surface and underground pools." This definition would include hot tubs that have a surface area of 100 sq.ft. or more!
- The owner of every "pool" shall erect and maintain an adequate enclosure surrounding the entire swimming pool area and sufficient to make such body of water not readily accessible to small children.
- Every enclosure shall extend from the ground for a height of not less than 6 ft throughout, and shall be measured from the exterior of same. Openings in any enclosure shall not exceed 4".
- Every enclosure having a gate or gates shall be equipped with self-closing and self-latching devices placed at the top and on the inside of the gate. No gate shall be less than 6' in height, nor of a width exceeding 4'.
- Buildings situated on the property on which the pool is to be constructed or erected may be utilized to effectively enclose any pool.
- Every swimming pool shall be equipped with a reaching pole; a first aid kit and buoys and rope.

This bylaw has continued to stay in force to prevent liability to you and the Town which means, if your pool does not comply with the bylaw and an incident occurs, you AND the Town could be sued.

Please ensure your summer swimming fun does not become an "incident". The bylaw can be viewed or a copy obtained from the Town Office.

#### **Hanley Housing Program**

The Hanley Housing Authority on behalf of Saskatchewan Housing Corporation, offers the Social Housing Program. This program is designed to ensure that safe, adequate housing is available to those who could not otherwise afford it. Our tenants benefit from a safe place to call home, a community they can enjoy and peace of mind.

#### **General Requirements for Housing**

Applicants must meet income and asset limit requirements to be eligible for the Housing Program. All applicants are required to complete an application form and provide verification of income and assets, as requested.

#### **Review Process**

Applications are reviewed for eligibility and approved by the Housing Authority Board of Directors. We utilize a point score system that considers adequacy, suitability and affordability when determining the priority of need.

Once approved, units are allocated upon availability on a priority based, point score system.

Additional Information Senior housing rent is based on income – 30% of gross household income, collected via pre-authorized payment.

Units are smoke free – No smoking in the units by tenants or guests. Housing tenants are responsible for obtaining and paying for their own power. Heat, water/sewer are included in the rent.

Any questions related to the Hanley Housing Authority should first be directed to the manager.

All requested income information and previous landlord references must be included or application will not be processed.

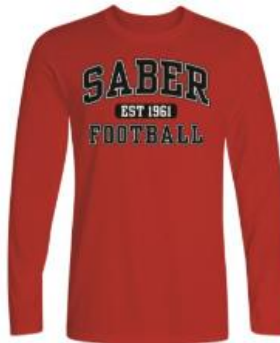

## TRANSFER STATION INFORMATION

### NOTICE OF ITEMS ACCEPTED AT THE TOWN OF HANLEY TRANSFER STATION

In accordance with our permit and Loraas Disposal the following items will **NOT** be accepted at the transfer station:

1. Tires;
2. Hazardous wastes of any kind: pesticides, chemicals which are radioactive, reactive, toxic, ignitable, corrosive, pathological, acidic, etc., or any waste which is otherwise listed as a hazardous or toxic substance;
3. Petroleum, petroleum remains or by-products;
4. Fuel tanks or oil barrels;
5. Asbestos, concrete, rocks, wire;
6. Petroleum contaminated soils;
7. Automobiles and other large metal objects;
8. Remains of or by-products of slaughter house operations;
9. Liquid domestic sewage, used oil, liquid wastes and sludges generally;
10. Liquid paints and solvents (dried material and empty cans are OK in the Loraas bin);
11. Acid-filled automotive batteries;
12. Propane tanks;
13. Any wood products treated with creosote (telephone poles, wooden pilings, railroad ties, etc.)

There are designated areas for steel. **ONLY TREES OR UNTREATED/UNPAINTED LUMBER MAY GO IN THE BURNING PIT.** Contact the Town Office regarding bin rental.

The Centennial Community Centre committee held their Annual General Meeting on April 16 with only 7 people present. These people are on the Executive along with representatives from the Town of Hanley, the RM of Rosedale No. 283 and the Hanley Seniors. The 2018 Audited Financial Statements were adopted as presented to show a deficit of \$5,355.58. Reports were received that: The floors were not redone this spring due to the deficit last year; and Ron Earis has repaired about 6 chairs last fall. Thanks Ron!

Executive positions were again elected:

Ken Froese – President;

Neil McRae – Vice-President;

There were no nominations or volunteers to act as members at large;

Darice Carlson volunteered to retain the position as Secretary for an additional year.

The Emergency Measures Committee will be supported in their pursuit of a stand-by generator with manual transfer switch for the Hall as it is designated as an evacuation centre in the event of an emergency.

There was some discussion in regards to funding for new audio/visual equipment.

## NOTES FROM THE TOWN OFFICE

### At our April Meeting:

The policing priorities for the Saskatoon Detachment were agreed to that have been set as follows:

Community Safety Through Crime Reduction (Rural Crime)

- 1) Enforcement – Prolific Offenders – Property Related Crime; Drugs; Traffic
- 2) Visibility – rural Patrols, School and Community Visits and Presentations
- 3) Intelligence Lead – Intel Gathering; Rural Crime Watch Groups, etc.

The street name changes have been an ongoing process with another bylaw having been passed to change 3 more streets from Street to Avenue.

A Road Maintenance Agreement policy was adopted and will form part of the Policy Manual.

A summer student position will be advertised.

The Town will celebrate Emergency Measures Week, May 5 to 11, by conducting a draw for residents of the Town of May 13/19. If you have registered with the Town that you live here, you will be in the draw!

The Town will be submitting an Expression of Interest to the Investing in Canada Infrastructure Program (ICIP) for rehabilitation to the lift station to accomplish an extension of the estimated useful life of this asset; and to build a stronger community and encouraging physical activity with the construction of artificial ice in the Hanley Arena.

The Hanley Preschool received approval to use the Spray Park with erection of a bouncy castle for their year-end party.

The Transfer Station Operations Plan was amended to include recommendations of the Ministry of Environment.

Vision Care was added to the Employee Benefits plan through SUMA Group Benefits with the employee responsible for 100% of the plan.

The 2019 budget was approved with the minimum tax being increased as per the 3-year plan initiated by the Council in 2017.

Capital investments that were budgeted this year include: upgrading the lift station (\$50,000); changing two hydrants (\$12,000 – one has already been changed); changing two water main valves (\$10,000); sidewalks (\$41,700); and 2 culverts (\$18,000).

The Town Office has been asked numerous times where the tax dollars are going. The budget is available to see at any time but you can see the percentages of where your dollar goes for each functional classification in the graph below. As you can see, the bulk of it goes to Transportation Services which includes salaries, street maintenance & repairs, dust control, gravel, vehicle registration, power & energy at the shop, the Foreman's cell phone, power to the street lights, shop supplies & small tools, maintenance and repairs to the shop and equipment, oil & gas, street sweeper rental, culvert & drainage maintenance, cold mix asphalt, and street signs. The Council also added \$10,000 to the equipment reserve for the future purchase of equipment (tractor/grader/mower, etc).

Protective services have the next large percentage. This includes \$23,500 for policing, a small amount for 9-1-1 dispatch services, emergency planning and \$25,000 is allocated to the new Fire Hall building.

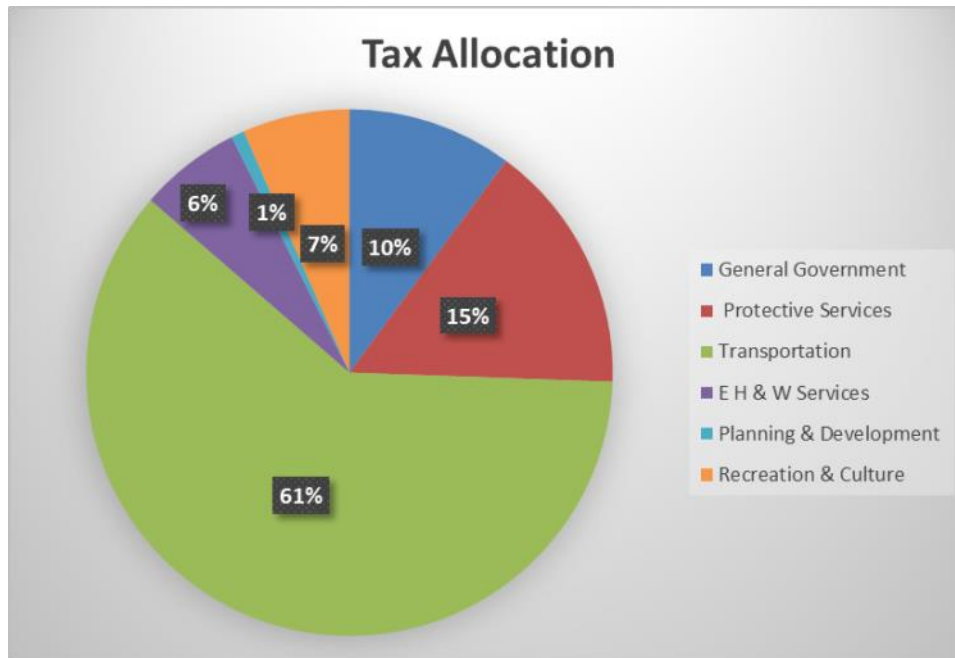
10% of your taxes goes to General Government which is a catch-all of expenses incurred in the Office which include: salaries, legal fees, audit (\$10,000), WCB levy, SAMA assessment services, advertising, workshops and conventions, office caretaking, insurance, memberships to associations such as SUMA and UMAAS,

webpage maintenance, software maintenance & support, Moneris fees for the use of debit and credit cards, bank charges, telephone and internet, stationary and postage, office supplies which included a new laptop, and photocopying and the lease for the copier. Lines such as the Building Official are covered in building permit fees and the Council plan to purchase more bunnyhugs which will be covered by their sales.

There was an increase to the Municipal Revenue Sharing Grant this year of \$3,000 to total \$106,289 and we are now collecting the SaskEnergy Surcharge and budgeted a \$10,000 revenue from that.



The 2019 Audited Financial Statements were approved.

### **At our May Meeting:**

The Council and Administration attended a meeting at the Arena at 7 pm on May 13 to hear the proposal that the Artificial Ice Committee is pursuing. This meeting was very informative in regards to another method of artificial ice. The Council then discussed how they could best provide assistance that may be requested by the Committee.

A “No-Thru Road” sign was approved and will be erected this summer.

The Inspection Reports that were completed in the Industrial Park for roads and the storm ponds were approved and a copy will be forwarded to each parties’ signatory to the Servicing Agreements.

It was noted during the inspections that the crossbucks on the Agvantage Rail were erected incorrectly so the Administrator was instructed to forward a letter to the rail owner including pictures of the current signage and a copy of the regulations for signage of crossbucks and Stop signs.

As requested by the President of Agvantage Development Corp at a special meeting in April, a reply was received by the Town from Federated Cooperatives. This reply will be forwarded to Agvantage Development.

The Dundurn Rural Water Utility (DRWU) Board requested a letter of acknowledgement and support of the new office building being constructed in the Town of Dundurn. A resolution was made to officially acknowledge the support of construction.

NOTES (cont'd)

The DRWU Board also requested an amendment to the Corporate Bylaw whereby the Directors appointed by the member municipal councils will no longer be affected by the 6 year “sunset clause” as each council may at any time appoint a different Director to the Board.

After attending a “Local Authority Freedom of Information and Privacy” webinar, the Administrator created a policy for Access to Information for the Council to review and approve. This policy will be added to the policy manual. Another change to the Policy Manual involved the recognition of change to *The Tax Enforcement Act* whereby the value of land regulatory requirement was increased from \$5,000 to \$17,500.

Landon Mooney was hired as the summer employment student so you will see him busy in the community in July and August!

The Transfer Station Rates were discussed again and a change will take effect after hearing what the RM of Rosedale Council decided at their last meeting in regards to the rates, usage of the facility and the deficit incurred annually.

As there are two tree stumps still remaining from “the big tree”, Council decided to hold a silent auction with bids to close at 5 pm June 3 and the funds will go towards the new Fire Hall. Be sure to get your bids in for a great cause to the Town Office by phone @ 306-544-2223 or come into the office to see the bid sheet so you can get a better bid in! Let’s raise some money for the new Fire Hall!

As the Minor Ball parents are working diligently to get diamonds prepared and improved for the season and they needed some gravel, the Council decided to donate the gravel necessary for improvements.

A stale-dated cheque was written off.

The Council will be providing support to the Ag Society by having expenses paid by the Town and reimbursed by the Ag Society for big ticket items less the GST. The Town receives 100% of the GST back so this should prove a big savings for the Ag Society!

The Council ratified the approval of the “people mover” located at the western end of Lincoln Ave. for advertising for this year’s fair being held July 12 & 13. Watch for advertising!

SUMA requested that the Town Council forward a letter to Finance Minister, Donna Harpauer in regards to sharing 33% of total cannabis excise tax revenues collected in the province to help municipalities meet the need for enhanced policing and effective administration processes.

**TOWN TIDBITS:****Did you know:**

The Hanley Town Office is willing to take e-transfers for bill payments but the onus is still on the person making the e-transfer to the Town. To make doubly sure that your payment has been received by the Town, send us a quick email telling us you sent it so we can reply. If you forget to confirm that way, make sure you keep an eye on the accounts that you are making the payment to. For example: if you make a \$100 payment towards your utilities, keep track of the date and check to see that it was applied to your utilities on that date or within a couple days of you e-transferring. The Office may not have time immediately to accept the transfer but we sure try to get it within a couple days.
