### **Another Winter Risk – Roof Collapse**

Oh, that dreaded snow. We know it's a fact of life, but that doesn't mean we should just leave it where it falls. Built-up and deep snow can lead to roof collapse, and when you add rain to a moderate amount of snow that can overload the structure and lead to collapse too.

To the best of our knowledge, the National Building Codes of Canada provide suitable structural strength for snow, ice and rain loading on buildings. However, building codes are only as good as the engineering and workmanship at the time of construction, and they cannot predict additional loading of the structure by occupant use or poor maintenance—not to mention the wear and tear that happens to any building over time.

### **Watch for these risk factors that can lead to building collapses:**

- Snow, ice and rain accumulations higher than those anticipated by the codes (AKA freak snow or rain storms)
- Drifting snow in isolated areas such as roof elevation changes or near large equipment which creates localized loads
- Poor workmanship and materials in the construction
- Inadequate engineering design
- Additional loading on the structure by the occupant (for example, hanging heavy loads such as storage from the building joists or beams)
- Roof elevation differences, especially where the lower roof is older than the higher roof

### **Check your roof drains**

- Are they blocked with debris?
- Are the filter caps in place to prevent debris from accumulating in the drainpipe?

Take immediate action to fix any problems.

### **Check the interior structural elements (beams, joists, columns)**

- Is there any evidence of corrosion, cracking, or damage?  
Are there any temporary loads suspended from these elements, such as large amounts of hanging clothes, racks or shelving?

Promptly involve facilities engineering and professional engineers to review any perceived problems with the structure, and remove any loads which would not have been anticipated in the original design.

### **Prepare a plan to for safe removal of snow from the roof if necessary**

We recommend using qualified snow-removal contractors who have adequate liability insurance coverage in place. This should be established ahead of time. If you plan to do this with employees, develop a detailed plan for removal. Employees should be fully trained, and the necessary tools should be on hand to accomplish this.

#### **Key points for a safe snow-removal plan**

- Avoid producing uneven or concentrated loading on the roof
- Secure areas onto which snow will be dumped from a roof to prevent access and potential injury
- Snow removal should use tools and procedures that will not damage the roof cover, flashing, skylights, etc.

Workers on a roof must use fall-arrest or travel-restraint equipment in accordance with the fall-protection requirements of the Occupational Health and Safety legislation. This ensures workers are protected from falling when undertaking such work. This may be accomplished by using guardrails and barricades, or other effective measures. Appropriate fall protection is required for work on all types of roofs, including flat roof structures.

A civil or structural engineer should be consulted to:

- determine whether snow loads are excessive;
- determine whether there are signs of structural distress;
- obtain a removal procedure that will not cause more structural problems; and/or reinforce a structure that is over-stressed.

#### **During the winter months**

Periodically check the roof for snow accumulations. Take note of drifting snow near roof elevation differences, signs, facades, and large equipment. Watch for areas of unusual ice accumulation. Keep a record of these conditions and report them to the facilities engineering.

Continue to check roof drains even if there is no snow on the roofs and rectify any problems.

Look for roof leaks and take temporary corrective action as necessary. Document the locations of leaks and report them to facilities engineering.

#### **Review snow depth in your area against historical norms and maximums**

The Weather Network provides useful information on current conditions and climate history. Current snow depth for your area can be found by selecting the weather station in your area. Keep in mind that ice, older snow, or wet snow will weigh more than new snow.

**If collapse appears imminent, vacate the building and contact the utilities or contractors to shut down gas, water, electricity and sprinkler systems if it is safe to do so.**

#### **Hanley Housing Program**

The Hanley Housing Authority on behalf of Saskatchewan Housing Corporation, offers the Social Housing Program. This program is designed to ensure that safe, adequate housing is available to those who could not otherwise afford it. Our tenants benefit from a safe place to call home, a community they can enjoy and peace of mind.

#### **General Requirements for Housing**

Applicants must meet income and asset limit requirements to be eligible for the Housing Program. All applicants are required to complete an application form and provide verification of income and assets, as requested.

#### **Review Process**

Applications are reviewed for eligibility and approved by the Housing Authority Board of Directors. We utilize a point score system that considers adequacy, suitability and affordability when determining the priority of need.

Once approved, units are allocated upon availability on a priority based, point score system.

#### **Additional Information**

Senior housing rent is based on income – 30% of gross household income, collected via pre-authorized payment.

Units are smoke free – No smoking in the units by tenants or guests. Housing tenants are responsible for obtaining and paying for their own power. Heat, water/sewer/waste are included in the rent. Yard maintenance is provided. One bedroom unfurnished units include 4 appliances.

## NOTES FROM THE TOWN OFFICE

### At our December, 2019 meeting:

Foreman Ben Collins attended the meeting to provide his report.

He had been busy obtaining quotes for used graders; has set up the blocks in the gravel storage area and they are working very well.

Councillor McGregor reported on he and the CAO having attended a WaterWolf (WW) workshop on Nov. 28. This summarized to attendees what the administrators have been working on at the GIS workshops. The WW budget was reviewed and approved by Council with no increase in fees for the coming year. He reported on the fees for each municipality for 2020 with WW paying for half the fees for the first year for the GIS mapping. A spreadsheet was developed from a survey of members to see what fees Loraas had been charging. This sheet will be discussed with Loraas to discover why there are discrepancies among the members

The Administrator reported attending Asset Management webinars on Levels of Service Development (Nov. 18) and Risk Management (Nov. 20). It was difficult to participate fully in these webinars as they are conducted during office hours.

The costs for the 2019 Hermes newsletters was presented to Council to discover that the costs have decreased by printing on 11" x 17" paper and not providing them in the mail boxes of people who do not wish to receive flyers.

She reported having to close the office on Dec. 3 to attend a funeral for her Aunt.

The Administrator reported on the Dundurn Rural Water Utility.

Because of the success of the solar panels with the substantial decrease in SaskPower charges, the Board is obtaining quotes for more solar panels at other pumping stations;

There has been discussion on a water fill station;

The office has moved to the new building as of Dec. 6. This is a great benefit to the staff for working conditions and the board table has its own spacious room rather than being in the middle of the office;

Purchased more "end point" Badger radios for replacements as needed;

The PDWA is on the Blackstrap line for the winter again;

Chairman Heidt and Manager Bellina are handling mediation and court for small claims court.

The regular meeting was held Dec. 18.

The Administrator reported that a washroom was finished in the new Fire Hall so the Fire Dept can move in any time. The council will be advertising for sale the "old Fire Hall" land and building.

The Waterworks bylaw was amended to prohibit situations where there may be a possible cross contamination.

The DRWU Corporate Bylaw was adopted

Councillor McGregor and Administrator Carlson will be attending the 2020 SUMA Convention in Regina in February.

Policy #200-6.5 regarding the Charitable Funds program was amended to read: Charitable donation funds will be collected and submitted to a donee in need of charitable funding, less the cost of credit card charges, as specified by the Town of Hanley.

The Council accepted the resignation of Councillor Andrea Townsend effective Jan. 2, 2020.

Employee wages were approved for 2020.

Some water/sewer/waste utility bills were applied to the tax roll due to non-payment.

Unpaid custom work was added to the tax roll of land owned by the person requesting the work.

The Canada Summer Grant funding will be applied for again in 2020.

The administrator was instructed to complete an Infrastructure Investment Plan for gas tax funding to upgrade the water meter reading system in the amount of \$10,248.87 to upgrade the water meters that are no longer covered under warranty. Some of the current meters have been in use since 2009!



NOTES(cont'd)

A subdivision application was approved for recently constructed SaskTel fiber optic infrastructure. A bylaw was passed for a water rate increase due to an increase imposed by the DRWU. The new rate is \$23.75/1000 ig with a minimum of 9000 ig per quarter \$213.75 per quarter. Accounts in the amount of \$146,844.96 were approved.

**At our January 2020 meeting:**

Developer Roy Dietz attended the meeting to query Council. A decision was tabled to the next meeting as only 4 Councillors were able to attend this meeting.

Councillor McGregor reported on WW:

- He attended the regular meeting Jan. 6;
- A discussion was held as to FCM funding for the next phase of the member's Asset Management planning;
- The WW Administrator has been obtaining quotes from engineering companies for the next round of Water System Assessments required in 2020;

A regular schedule of council meetings was set as per the current policy where they are conducted on the second Monday of every month except where a stat holiday falls on that day.

The Administrator reported:

- having spoken to Milt Miller of Providence Grain of future plans;
- the premium breakdown by location was provided for information;
- Munisoft has eNotices available for the tax program now. A notice will be sent out in the next utility bill asking if people would be interested in receiving their tax notices by email. The program is on sale this year as a promotion so if you would be interested in this, please contact the Town Office;
- An insurance claim for sewage backup was reported to SUMAssure.

The Administrator provided the DRWU agenda, minutes and newsletter.

A report of expenses for all Town recreational facilities was provided to Council.

The Sidewalk Asset Management Plan was finalized and adopted to be attached to the current AM Plan.

Councillor McGregor was appointed as voting delegate for the SUMAssure AGM at the 2020 SUMA Convention.

The list of lands in arrears was presented to Council with lands in arrears of less than ½ the previous year's levy being removed from the list and the list will be advertised in one issue of the Davidson Leader.

The assessment appeal fee was set at \$500 per appeal.

The Board of Revision will be remunerated as per fees set by Gord Krismer and Associates Ltd.

An updated Certificate of Insurance from SUMAssure for employee bonds was presented to Council.

The unaudited 2019 water, sewer and waste financial statements were accepted.
