## NOTES FROM THE TOWN OFFICE

### At our February meeting:

The CAO reported that more Badger meters have been installed. Notice was provided to those people that they are now able to download an app that will show the water usage.

Mayor McGregor reported on having attended WaterWolf meetings. The CAO reported on having recorded a presentation along with 3 other WaterWolf member administrators and the consultant that has been working with WaterWolf members. The recording was for the Infrastructure and Asset Management

Alberta conference. The presentation was very well received by different people in Alberta because it was a good representation from smaller communities.

The CAO reported that she and Admin Assistant Charrone White attended a number of webinars including the Municipalities of Saskatchewan convention.

The CAO reported having updated the Quality Assurance/Quality Control, the Waterworks Emergency Plan and the Town's Emergency Plan to reflect the Mayor and Deputy Mayor changes.

The CAO was instructed to send a Thank You letter to the RM of Rosedale No. 283 for the annual donation to the Town to help with costs associated at the Arena. A spreadsheet of recreational facilities expenses was presented to Council to be included in the letter to the RM.

The Fire Chief is organizing training sessions with other departments so the contractor is to focus on completion of the training room then keep working on the rest of the Fire Hall to completion. Flooring has been ordered and the electrician has the lighting on order.

A Building Permit summary was presented to Council. There were only \$53,000 worth of permits issued for 2020 along with 2 separate development permits.

The Human Resources Committee met on Jan. 28 to review salaries and to discuss the new Administrative Assistant and her progress going forward. It was decided that due to legal implications, an office cell phone would be purchased.

Councillor Prosofsky reported on the Arena and the success they have had this COVID winter. The power and energy bills will be re-directed through the Town and invoiced back to the Arena to assist in the collection of GST for those invoices.

Councillor Richardson received a quote for a microchip reader that Council decided could be purchased to aid in identification of pets. A number of concerns were received by the Council in regards to an off-leash dog. The owner was to be reminded of the Animal Control Bylaw.

A policy on "Personal Days" was adopted to allow for 3 personal days, or 24 hours, over the course of the fiscal year with a minimum of 4 hours per use. The personal days will not be carried over to a succeeding year and under no circumstances will an employee, upon termination or otherwise, be paid out for any personal time.

The utility surplus was transferred to the Utility Reserve account as required by the Saskatchewan Municipal Board.

A resolution was made to support the 2021 Census and the Council will encourage all residents to complete their census questionnaire online when available.

An offer to purchase Lot 24, Block 26, Plan H5352 was accepted by the Hanley Golf Club.

Accounts in the amount of \$91,937.67 were approved for payment.

## **NOTES FROM THE TOWN OFFICE (cont'd)**

### **At our March Meeting:**

The CAO and Assistant again attended a number of webinars. One of those was with SouthEast College in regards to the development of a Safety Plan. The CAO presented a number of quotations from different companies and the Council chose to use Campbell Safety Consulting for the development of the plan.

The CAO presented the Council with the Wastewater Emergency Response Plan (ERP), the Transfer Station ERP and the Transfer Station Operations Plan so they become aware of additional responsibilities.

The CAO will be meeting with 5 other municipalities to work on the Zoning Bylaw. The group was approved for grant funding from Targeted Sector Support to develop a new Bylaw.

The CAO attended the DRWU meeting on Feb. 24 and reported on operations. The DRWU Finance Committee met virtually on Mar. 9. The CAO was instructed to send a letter to the Resort Village of Thode to the effect that correspondence to the DRWU was misdirected that should have been sent to the partner municipalities; and that this Council desires to enter into negotiations again to draft a Corporate Bylaw that would be acceptable to all partner municipalities.

Two building permit applications were reported.

Correspondence was received from Building Official Meridan Inspections of his retirement plans as of April 30, 2021. The CAO will send him a letter of thanks for his years of service to the municipality.

An updated Code of Ethics Bylaw was adopted.

Council remuneration for committee meetings was discussed. Council members will be indemnified \$25 per hour for committees and boards to which they are appointed to as per the applicable section of the Policy Manual unless otherwise authorized through resolution of Council.

Council will aggressively be assessing Nuisance Properties in 2021 and will be discussing this further at the April meeting.

A letter of Certificate of Completion can now be provided to Agvantage Development Corp and Blairs Fertilizer Ltd.

The CAO was instructed to apply for the Healthy Communities Fund, first round, in the Public Spaces and Improved Mobility themes, for the amount of \$250,000 for the replacement of 21,550 square feet of "poor" and "very poor" sidewalks, with the exception of Sidewalk 28C, as per the Sidewalk Asset Management forecast.

CAO vacation days were approved for one day per month dependent on the Administrative Assistant's availability.

No applications were received for the position of Animal Control Officer. The application period is to remain open for an additional month. If no applications are received, the Council will consider an outside contractor for the position.

The Finance Committee set a meeting date to review the budget.

Accounts in the amount of \$93,923.22 were approved for payment.

### **Other notes and Thank you:**

Thank you to Ron Earis, Neil McRae and Brian Wolfe for changing out the ceiling tiles in the Clubroom of the Centennial Hall!

Remember if you have concerns about the waste and recycling pickup service, this is provided by Loraas Disposal and they can be contacted at 306-242-2300.

**DID YOU KNOW?** That, in an urgent situation, you can call the TIPPS (Turn in Poachers and Polluters Service) line if you see a wild animal that could be a danger to the community? 1-800-667-7561.

If you have a concern about the deer that were here this winter or any other Conservation concern, you can call the Conservation Officer Service at 306-933-6240.

## NOTES FROM THE TOWN OFFICE (cont'd)

**Did you know:** monthly utility payments and taxes will be accepted at the Town Office? It is very costly to do a utility billing so rather than the office providing monthly billing you can pay monthly. If you pay for the month you are using the water/sewer/waste then by the time the bill comes out, your bill should be \$0 unless you have used more than the minimum charge but you can make that up when you make your next monthly payment.

For example: the minimum quarterly utility charge is \$410.25 (unless you have paid out your Infrastructure Fee).

If you divide this by 3 months you could pay \$136.75 each month. The billing occurs AFTER you have used the services so if you are billed in March, you have used the water, sewer and waste services in January, February and March. If you pay \$136.75 in January, February and March, for example, your bill at the end of March should be \$0.

The water meter reads are electronic so unless your meter isn't working, the readings will be accurate. If the Office discovers that your meter isn't reading, we will schedule a time to switch the meter out to the new Badger metering system.

The same payment plan would also work for your taxes. Since the taxes have not been levied yet for 2021, you could look at your 2020 Tax Notice (or call the Town Office at 306-544-2223 or text at 639-213-7999), divide the levy by 12 months and make that payment each month. The taxes are due December 31 in the year of which levied so by the end of the year your taxes could be \$0. You will receive discounts on the municipal portion of your taxes as stated on your Notice (5% from January 1 to July 31; 4% till Aug. 31; 3% till Sept. 30; 2% till Oct. 31.) There is no discount in November or December.

## ANIMAL CONTROL

The Town is still looking for an Animal Control Officer. If you are interested, please contact the Town Office for more information (call 306-544-2223; call or text—639-213-7999; email [townahanley@sasktel.net](mailto:townahanley@sasktel.net))

There has been a few comments or complaints about animal control not dealing with people who do not pick up their pet defecate.

In order to be able to do a citation, the owner has to be witnessed. If witnessed, the complainant would then be required to fill out a Bylaw infraction report. Pictures of action would be an asset.

Without a Bylaw infraction report there is no legal grounds to discuss anything with owner of pet.

A Bylaw infraction report needs to include:

**Date of Occurrence:** (yyyy/mm/dd)

**Estimated Time of Occurrence:**

**Animal Description:**

(include type, colour, size and license number if available)

**Suspected Animal Caretaker:** (if available)

**Description of Incident:**

**Evidence Collected:** (pictures, additional witnesses, video, audio recording)

**Name of Complainant:**

(will be kept confidential unless otherwise ordered by court of law)

**Signature of Complainant.**

Please be a **responsible** pet owner and keep your pets licensed, under control and cleaned up after!

### TRANSFER STATION INFORMATION NOTICE OF ITEMS ACCEPTED AT THE TOWN OF HANLEY TRANSFER STATION

In accordance with our permit and Loraas Disposal the following items will **NOT** be accepted at the transfer station:

1. Tires;
2. Hazardous wastes of any kind: pesticides, chemicals which are radioactive, reactive, toxic, ignitable, corrosive, pathological, acidic, etc., or any waste which is otherwise listed as a hazardous or toxic substance;
3. Petroleum, petroleum remains or by-products;
4. Fuel tanks or oil barrels;
5. Asbestos, concrete, rocks, wire;
6. Petroleum contaminated soils;
7. Automobiles and other large metal objects;
8. Remains of or by-products of slaughter house operations;
9. Liquid domestic sewage, used oil, liquid wastes and sludges generally;
10. Liquid paints and solvents (dried material and empty cans are OK in the Loraas bin);
11. Acid-filled automotive batteries;
12. Propane tanks;
13. Any wood products treated with creosote (telephone poles, wooden pilings, railroad ties, etc.)

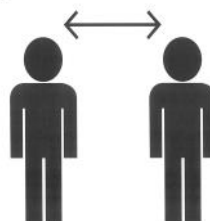

**RULES RULES RULES!**

Now that spring has seemingly sprung, we are all itching to get outside and use those fire pits. For your safety, and the safety of those around you, we have the following measures in place:

- 1) Open cooking fires shall not be set unless the following measures are taken:
  - a. Be limited to a diameter of 75 centimeters and be contained in a non-combustible receptacle;
  - b. The receptacle must be covered with a heavy gauge metal screen;
  - c. The receptacle must be located on a private property and be at least 10 feet from any property line or combustible structure;
  - d. The receptacle must be separated from any grass or vegetation by at least 40 centimeters.

General regulations also require that the fire be reasonable supervised, appropriately ventilated, fueled only by approved substances (charcoal, cut seasoned wood, or manufacturer logs), not be set in windy conditions that could result in a running fire or nuisance to another person, and the smoke from the fire may not cause unreasonable interference with the use and enjoyment of another property.

For all open fires, a permit (Bylaw 13/11, Schedule A) must be obtained prior to igniting a fire of any kind.
