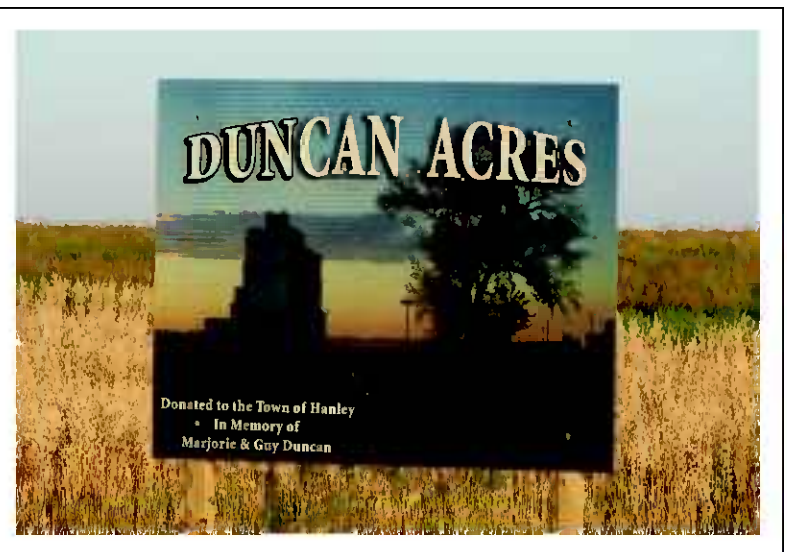

New Dishwasher

There has been a little difficulty with the operation of the dishwasher. The most important difference between this machine and the old sanitizer is that you must turn the dishwasher on **20 minutes** before you wish to use it to give it time to heat up. Also you must pull up the drain plug for the dishwasher to drain. This is a silver cylinder on the right hand side. Please follow the **directions** posted on the **cupboard above the dishwasher**.

All of the buttons have been labelled according to the numbers on the direction sheet. Thanks to Dale Bagnall for assisting those new to the operation of the machine.

Dishes Left at Hall

Residents who have donated food to functions and have not picked up their dishes, are encouraged to do so. Included in the collection are two crock pots, a stock pot, a chrome dutch oven, quite an assortment of cake and pie plates. They have been placed on a table in the foyer and may be picked up any time Monday to Friday during the day. Any dishes left after September 15, 2009, will be packed away as it is kind of difficult explaining to the health inspector why the dishes are in the furnace room when food is not supposed to be brought into the hall!

Fire Inspection

The dept. of Health and Safety did a recent inspection. The following deficiencies were identified: exit signage, need down-spout extensions and/or splash blocks, filters in grill must be removed and replaced with an approved brand of filter. The Board will address these issues this fall.

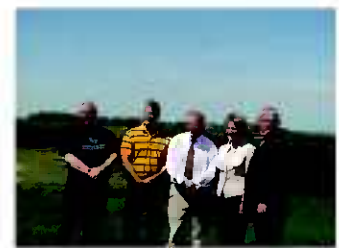

The meeting was called to order at 7:00 p.m. by Mayor Gerbrandt.

MINUTES 118/09 DeRegt/Ballard: That the minutes of the regular meeting held on June 8, 2009 be approved. CARRIED.

APPOINTMENT: 119/09 DeRegt/Ballard: That we appoint Ann Rogers as Spokesperson for the delegation attending the meeting regarding the Animal Control Bylaw CARRIED.

FIN.STAT. 120/09 Ballard/McGregor: That the statement of accounts for the month of June, 2009 be approved. CARRIED.

MAINTENANCE REPORT: Foreman Terry Block presented the maintenance report.

FIN.STAT. 168/09 Ballard/McGregor: That the statement of financial activities for the month of July, 2009 be approved. CARRIED.

DELEGATION Ann Rogers spoke on behalf of a delegation of citizens concerned about a drafted Animal Control Bylaw.

CARRIED.

FIRE DEPT – Councillor Sira reported that the Fire Hall building needs an appraisal or fair market value to approach the R.M. of Rosedale No. 283 with an amalgamation proposal.
